## This is a sample of the report

Due to the delayed possession of the Englemere site, and under clause 4.19 of the D&B 2016 JCT contract the contractor is entitled to claim for direct loss and/or expense as a result of the progress of the works being materially affected by relevant matters for which the client is responsible, such as failing to give the contractor possession of the site clause 2.4. (JCT, 2016)

The nature of the claim will comprise of costs resulting from the delay to the works commencement date. Prolongation costs are the additional nosts arising from delay to completion of the contracted work. The contractor will almost certainly incur additional nosts as a result of having to remain on site for a longer period than anticipated, which will lead to additional labour costs, plant costs, off-site overheads, fluctuations and so on. (Hackett & Statham, 2016, p318)

The Englemere contractor must give written notice of a claim as soon as it becomes reasonably apparent that the regular progress of the works is being materially affected. This need not necessarily result in a delay to the completion date, and so claims for loss and expense and claims for extensions of time do not necessarily always run together.

As part of any claim for an extension of time, the Englemere contractor must be able to prove and demonstrate that the delay in question is responsible for the effect on the completion date. The
